- For 2023 approved Permissive Tax Exemption recipients, a Renewal application is required. Please complete the enclosed application

Please ensure applications include all required information and that they are submitted on (or before) the deadline of June 30, 2023 at 4:00 p.m.

Incomplete and late applications will not be accepted.
