hereby enter into this agreement for bulk water purchasing and for other good and valuable consideration. The Purchaser hereby accepts the following terms and makes the following undertakings with respect to their purchase of bulk water from the Town of Golden ("the Town") and their use of Town facilities for same.

1. The Town only ensures water potability to point where water is dispensed from the water fill station. The Purchaser is responsible for using appropriate hose type, appurtenances, and hauling tank to ensure water potability beyond this.
2. The Town's automated bulk water fill stations are accessible year-round. The Town reserves the right in its sole discretion and without notice to shut down a bulk water fill station, at times, to perform scheduled and/or emergency maintenance.
3. To report an issue or concern please call 250-344-2271. For After Hours Emergencies, please call 1-866-951-7449.
4. The Town makes no representations or guarantees regarding either: (a) the reliability or consistency of water availability at its fill stations, or (b) the quality or suitability of the water with respect to turbidity, odor, mineral content, or other factors. If the Purchaser has particular needs concerning water quality, it is up to the Purchaser to conduct any necessary or prudent tests of the water upon delivery.
5. The Purchaser acknowledges and agrees that it accepts the water in the quantity and quality delivered and the Purchaser agrees to release and forever discharge the Town and its mayor, council, officers, employees, agents, insurers, and affiliates, as well as the Province of BC from and against all claims, demands, actions, suits, damages, liabilities, losses, settlements, judgments, costs and expenses (including but not limited to reasonable attorney's fees and costs), which it may at any time hereafter have which arise out of or relate to this agreement or to the Purchaser's purchase, delivery, re-sale, use, or disposal of the Town's bulk water and related facilities.
6. The Purchaser is responsible for providing tank, hose and connector, including O-ring to prevent any leakage. Without limiting the release and indemnity provisions herein, the Purchaser accepts any and all risks while attending at or travelling to or from Town facilities.
7. The Purchaser shall be liable to the Town for all direct and indirect costs arising from any damage or contamination to the facility including all equipment at the fill station arising in whole or in part out of the Purchaser's use of the fill station
8. The Purchaser acknowledges being advised that potable bulk water is available for purchase at rates set out in the Town of Golden Water Systems Rates and Regulations Bylaw and as updated from time to time, as approved by Council.

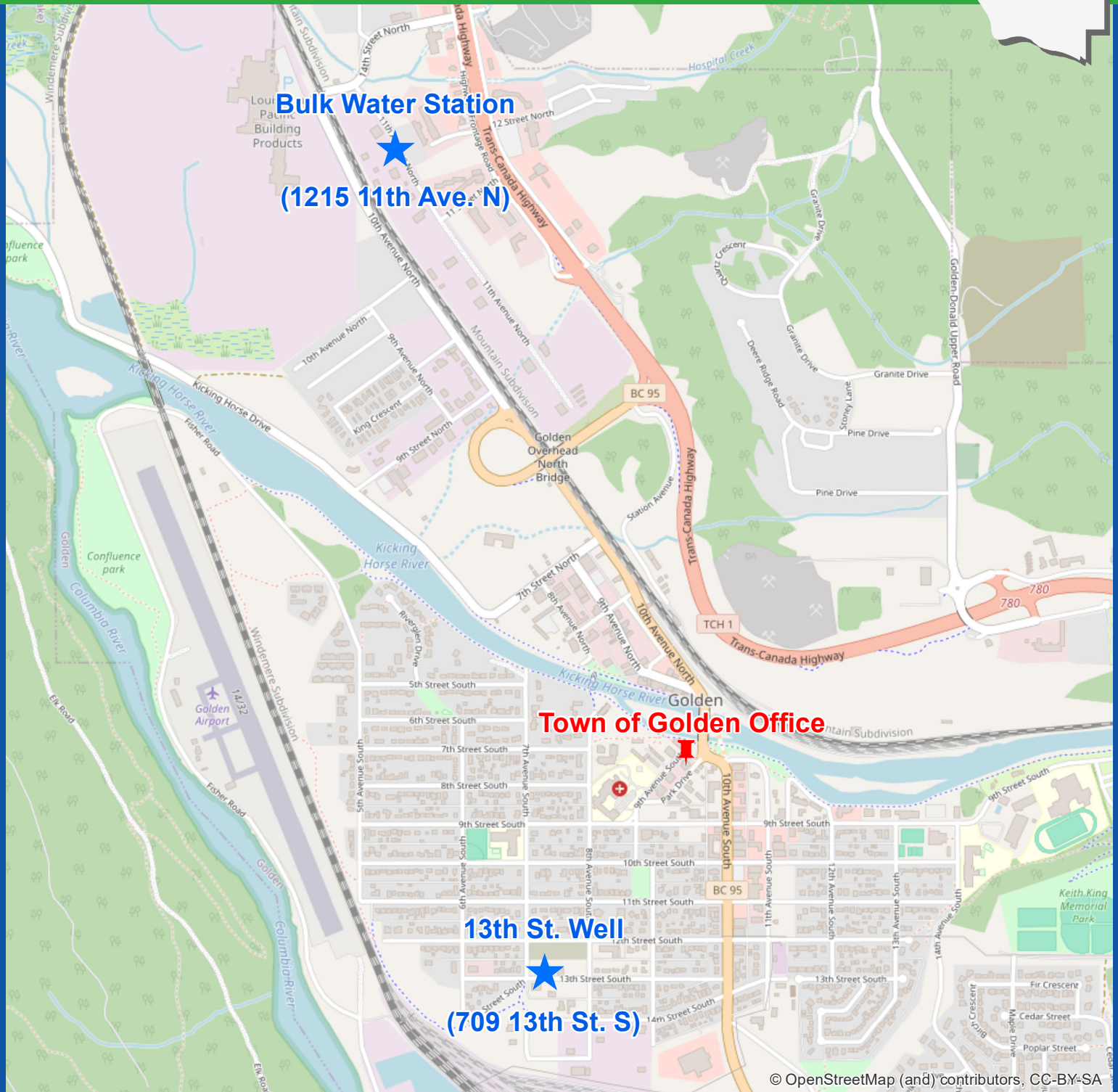

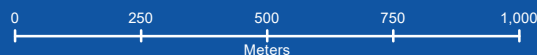
Bulk Water Station/Well
